Comments: The Oregon Range is 21600 sq. km, including range of Survey and Manage sites. It occurs in the Cascade Mountains

Population Size: Not assessed

Comments: None

Number of Occurrences: C = 21 - 80

Comments: There are 50 known occurrences in Oregon (includes four S/M records).

Area of Occupancy: E = 26-125 4-km² grid cells

Comments: This species occupies about 90 grid squares in Oregon.

Good Viability: C = Few (4-12) occurrences with excellent or good viability or ecological integrity

Comments: There are 7 sites in Wilderness Areas.

Environmental Sensitivity: B = Narrow. Specialist or community with key requirements common

Comments: This "snowbank" mushroom is a decomposer of woody debris in high elevation conifer forests

Threat Impact: C = Medium

Comments:

Approximately 85% of the known sites are not in protected areas. If those sites are logged on a 40 year rotation, then around 21% of the sites would be impacted over 10 years and around 85% would be impacted
